 - a) Consultation pursuant to TX Govt. Code Sec. 551.074 regarding Personnel Matters and pursuant to TX Govt. Code Sec. 551.071 to receive legal advice regarding an audit.

 - b) Pursuant to Texas Government Code Section 551.072 – to consult with attorney regarding the Project Inspection Services for the Airfield Electrical Improvements at Valley International Airport, in accordance with the scope of services outlined in the RFQ, pending FAA Grant offer and acceptance.
