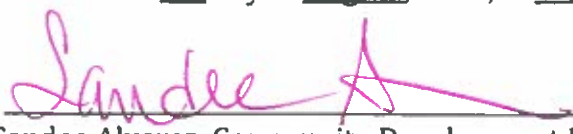

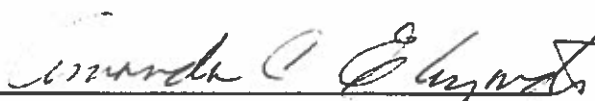
PUBLIC NOTICE
